

The Big Green Egg® Small Sweepstakes

Official Rules:

Eligibility: Sweepstakes (the "promotion") is only open to legal residents of the 50 United States, the District of Columbia and Canada who are 18 years or older with Internet access at time of entry. Only entrants logging onto the Internet from within the 50 United States, the District of Columbia or Canada are eligible to enter the Sweepstakes. The following persons are not eligible to enter the Sweepstakes: (a) employees of Bernatello's Pizza, Inc.
